

Privacy notice on the processing of personal data pursuant to art. 13 and 14 of European Regulation 2016/679/EU

Pursuant to Articles 13 and 14 of EU Regulation 2016/679, the following privacy notice is provided, in compliance with the principle of transparency, in order to make people aware of the characteristics and methods of data processing:

c) Purpose of the processing and legal basis

The processing of personal data requested from the data subject is carried out for the performance of a task of public interest or related to the exercise of public authority pursuant to Article 6, paragraph 1, letter e) of EU Regulation 2016/679 for the following purpose: execution of voting operations electronically through the ELIGO e-voting platform for the election of student representatives who will go to set up the Students Assembly, as a body provided for within the UNITA Alliance - mandate 2025-2027.

d) Types of data processed

The personal data processed by the Joint Controllers for the purposes indicated above are as follows:

- personal data;
- contact details;

Specifically: username, name, surname, serial number, e-mail address.

For the aforementioned purposes, special category personal data are processed by the Data Holders in accordance with Article 9 of the EU Regulation 2016/679, namely:

- data related to the political orientation of the candidates belonging to the different lists.

e) Provision of data

The provision of personal data is mandatory, in case of failure to provide personal data it will not be possible to participate in the voting operations for the election of the Student Representatives who will constitute/compose the UNITA Student Assembly.

f) Processing methods

The processing of personal data will take place using IT and telematic tools that are in any case suitable for guaranteeing the security and confidentiality of the data. The elections will take place via electronic voting using the "ELIGO" software - e-voting IT platform.

g) External Data Processors

For the purposes related to the processing activities relating to the electoral operations of the representatives of the Alliance's Student Assembly, UNITA-GEIE" (European Economic Interest Grouping) as an instrumental body of the UNITA Alliance and full partner of the European Project UNITA – UNIVERSITAS MONTIUM, on behalf of the Joint Data Controllers, designates, with a specific deed, the company ID Technology srl, which provides the "ELIGO" Software, as Data Processor, pursuant to and for the purposes of art. 28 of EU Regulation 2016/679 (GDPR).

h) Data transfer to third countries

The Joint Controllers do not transfer, either directly or through third parties, personal data to countries outside the European Union or international organizations.

i) Data retention period

Personal data are stored for the time strictly necessary to achieve the purposes for which they were processed in accordance with art. 5, § 1 letter e) of EU Regulation 2016/679, it being understood that these are personal data that are and remain available to the respective universities for the achievement of the primary institutional purposes related to the processing of student data.

The Data Processor (ID Technology srl, which provides the "ELIGO" Software, pursuant to Article 28 of EU Regulation 2016/679 undertakes to completely delete the Personal Data processed at the end of the execution of the service offered for voting operations.

j) Data Rights

The data subjects (subjects to whom the data refer) may assert, in the cases provided for, their rights on personal data pursuant to art. 15-21 of EU Regulation 2016/679, where applicable, against each Joint Controller pursuant to art. 15 et seq. of the GDPR by sending a specific request with the subject: "privacy rights" to the reference email address indicated as the contact point for each joint controller:

k) Complaint
